Agreement:

An Agreement made on the _____ Day of _____, 2022, between the City of Apopka, 120 E. Main Street, Apopka, FL 32703, (hereinafter called "The City") of one part and _____ (hereinafter called "Sponsor") of the other part WHEREBY IT IS AGREED:

2. **Benefits to Sponsor**

- c. This event will be held February 11 & 12, 2022, rain or shine. This agreement will be respected regardless of weather or attendance at the event.
