#### **SUMMARY:**

On September 16, 2020, by Resolution Number 2020-30 the City Council adopted the final budgets for fiscal year (FY) 2020-2021. The City has committed to expenditures and has experienced unanticipated revenues/expenditures through the current fiscal year that need to be reflected in the budget. Florida Statutes, Section 166.241(4) requires the governing body amend the budget in the same manner as the original budget is adopted. Below are the following proposed amendments:

1. Amendment: Billing for Awarded Contract on Unbilled or Misbilled Utility Services.

Funding Source: Reserves

Description: Water Company of America was awarded a piggyback contract as a consultant for utility revenue enhancements. Their scope of services includes the analysis of the water, wastewater, and reclaimed water system to correct any system under-billings and mis-billings. City Council approval for the piggyback contract was April 15, 2020 and work began in FY 2021. The first billing cycle was received at the end of FY 2021 from Water Company of America. This amendment is to provide payment for the total cost of their contracted services in FY 2021.
